## Historical Data and Content

Associazione N.9 publishes, among other things, historical and genealogical information from public sources. Furthermore according to Italian law, precisely with art.11 of "Deontological rules for processing for archiving purposes in the public interest or for historical research purposes" ("Regole deontologiche per il trattamento a fini di archiviazione nel pubblico interesse o per scopi di ricerca storica", pubblicate ai sensi dell'art. 20, comma 4, del d.lgs. 10 agosto 2018, n. 101 - 19 dicembre 2018), "at the time of dissemination of the data, the principle of relevance is evaluated by

the user with particular regard to the individual personal data contained in the documents, rather than to the documents as a whole. The user can disclose personal data if pertinent and indispensable for research and if they do not harm the dignity and confidentiality of individuals” (comma 4) and “the user may use the processed data or copies of documents containing personal data, accessible with authorization, only for the purposes of his own research, and shall also ensure confidentiality with respect to third parties” (comma 5).
